ADA Component Dental Societies and Affiliates of Participating Specialty Organizations Approved through the Extended Approval Process

In the spring of 1996, the ADA CERP Committee adopted procedures for ADA constituent dental societies that have received ADA CERP provider recognition to conduct a review and extend ADA CERP approval to their component societies that offer continuing education primarily to their own members. Subsequently the American Dental Association of Endodontists (AAE), the American Academy of Oral and Maxillofacial Pathology (AAOMP), and the American Association of Orthodontists (AAO) have been authorized to conduct the Extended Approval Process for eligible affiliates.
