**Released Item Sets:** This collection of examination materials includes questions compiled from examinations administered by the Joint Commission on National Dental Examinations from approximately 2000-2008.

**Pilot Examination:** In 1996, the JCNDE administered a pilot examination of the revised case-based NBDHE format. The revised format emphasizes patient problems and assesses the abilities of candidates to use their knowledge of dental hygiene. A series of patient cases are presented, and each case is followed by multiple-choice questions pertaining to the case.
