

**UNOFFICIAL REPORT OF MAJOR ACTIONS
COUNCIL ON DENTAL PRACTICE
May 12-13, 2022**

The Council on Dental Practice (CDP/the Council) met on May 12-13, 2022 at the ADA Headquarters Building in Chicago. The following is a summary of major actions taken by the Council.

1. Elected Dr. Manish Chopra of Ohio as its next chair and Dr. Jeffrey C. Ottley of Florida as vice chair for 2022-2023.
2. Agreed to use the ADA Diversity, Equity and Inclusion lens in its decision-making and support the Champions Network to advance diversity and inclusion across the tripartite.
3. Discussed the Council on Government Affairs (CGA)'s proposed Family and Medical Paid Leave policy for dental offices. CDP does not support the proposed policy; agreed that a policy is not needed and directed staff to research Family and Medical Leave legislation by state and compile this information for members.
4. Approved the proposed dental implant card for patients to address Resolution 107H-2021 (*Trans.*2021:000) Standard Form for Consolidating Dental Implant and Implant Restoration Data.
5. Supported the concept of an ADA allied membership category proposed by the Council on Membership.
6. Approved the preliminary agenda for the 2022 Elder Care Symposium hosted by CDP.
7. Approved six candidates submitted by the Health, Wellness and Aging Subcommittee as members on the Dentist Health and Wellness Advisory Committee and as CDP consultants.
8. Approved the Dentist Wellness Advisory Committee January 21, 2022 and March 4, 2022 meeting minutes.
9. Approved the National Elder Care Advisory Committee January 14, 2022 and March 25, 2022 meeting minutes.
10. Recommended that 24 policies reviewed by CDP per the ADA five-year review cycle be retained as written.
11. Agreed with CGA's proposed amendment to 74H-1999 Activity to Stop Unlicensed Dental or Dental Hygiene Practice (*Trans.* 1999:949) and will notify the CGA.
12. Approved the appointment of Council consultants with terms ending after the close of the 2023 meeting of the ADA House of Delegates.
