

ADA COUNCIL ON ETHICS, BYLAWS, AND JUDICIAL AFFAIRS Minutes of the September 8, 2021 Special Meeting

The special meeting of the Council on Ethics, Bylaws, and Judicial Affairs (CEBJA or the Council) was called to order at 7:00 p.m. on Wednesday September 8, 2021. Council chair Dr. Robert J. Wilson, Jr. presided at the meeting which took place via Zoom videoconference.

Following a welcome to the Council members attending the meeting, staff and guests, Dr. Wilson requested that a roll call be held:

Agenda Item No. 1: Discussion of Proposed Further Amendments to the Resolution and House of Delegates Worksheet Previously Adopted by the Council Entitled "Proposed Amendments to the Comprehensive ADA Policy Statement on Teledentistry"

Resolved, that a copy of the revised resolution be appended to the minutes of the meeting.

Upon a show of hands, it was announced that the motion to approve the revised resolution and House of Delegates worksheet was adopted. A copy of the revised resolution will be appended to the minutes of the meeting.
