18	CDT CODE MODIFIERS
19 20 21 22 23 24	CDT Code Modifiers: The Council had a general discussion of the Enhanced CDT Code project to prepare for the in-depth review of the project task force initial report at the May Council meeting. Discussion topics included the concept of procedure code modifiers, the pros and cons of an enhanced CDT Code versus continuing with the code set's current architecture, and the effects of any Council decision on dentists in practice and others in the dental community – both in the near and long term.
