Advocacy

Organized dentistry must engage policymakers at the federal, state, and local levels to ensure that legislation is passed that is supported by evidence based information. As dentists, we must establish and maintain the ability to operate our businesses and provide quality and affordable care for our patients. Our advocacy must protect the sanctity of the dentist-patient relationship from unnecessary government and third-party interference.



Dental Insurance Reform

Addressing dental insurance reform is our most important issue. The ADA led the efforts to get McCarran-Ferguson reform passed in Congress and is supporting and assisting state dental associations in getting other dental insurance reforms, like noncovered services and dental medical loss ratio laws, passed in states across the country. We need to continue to make this a priority.
