



Official Rules for the SmileCon 2023 Meta Quest 2 Virtual Reality Headsets Prize

No Purchase Required to Enter or Win

- 1. Eligibility:** The **ADA SmileCon® 2023 Meta Quest 2 Sweepstakes** (Sweepstakes) is open only to persons who: (a) are legal residents of one of the fifty (50) United States, the District of Columbia, or the U.S. Virgin Islands; (b) are eighteen (18) years of age or older and (c) participate in the Career Paths virtual reality experience at SmileCon 2023, take the post-experience survey and provide their name and email address, as detailed below. Vendors of the American Dental Association ("ADA"), exhibitors at SmileCon® 2023, officers, directors, trustees, and employees of the ADA, or any affiliate of the ADA, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such individual, are not eligible. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited by law.
- 2. Sponsor:** The Sweepstakes is sponsored by the American Dental Association, 211 East Chicago Avenue, Chicago, IL 60611 (Sponsor).
- 3. Agreement to Official Rules:** Participation in the Sweepstakes constitutes Entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon fulfilling all requirements of these Official Rules.
- 4. Sweepstakes Prizes:** Two (2) Meta Quest 2 Virtual Reality Headsets will be awarded.
- 5. How to Enter:** To enter the Sweepstakes, (a) visit the ADA Hub, Booth 2339 in Dental Central at SmileCon® 2023 during the exhibition hours on October 5-7, 2023; (b) participate in the Career Paths Discovery: A Virtual Reality Experience; (c) scan the QR code and take the survey, providing your name and email address in the survey. You will then be entered into a drawing for the prizes. If the survey link is sent to you via email and you respond with your name and email in the survey, you will likewise be entered in the drawing. The Sweepstakes will close at 12:00 p.m. CT on October 13, 2023.
- 6. Drawings:** At approximately 3:00 p.m. CT on October 13, 2023, the Sponsor shall select the name of two (2) potential winners for the Prizes in a random drawing from all valid and eligible attendee badge scans made by the Sponsor at the ADA Hub up to closing of the Sweepstakes. Two entrants selected shall be deemed to be the potential winners of the Prizes for which the Entrant's name was drawn. Entrants need not be present to win. The Sponsor will attempt to notify the winners within fourteen (14) days of the drawing. The manner and timing of notification is at the discretion of the Sponsor and may be modified or adjusted in such a manner as the Sponsor deems to be appropriate in its sole and absolute discretion.
- 7. Odds:** The odds of being selected to receive one of the Prizes depend on the number of entrants entered into the Sweepstakes.
- 8. Requirements of the Potential Winner:** Except where prohibited, a potential winner may be required to complete and return an IRS Form W-9 (W-9) and an affidavit of eligibility and liability/publicity release (the Affidavit/Release) within seven (7) days of being notified. If the potential winner fails to return the W-9 and the Affidavit/Release within the required time period, an alternate entrant may be selected to receive the Prize in question in their place from a random drawing of all remaining eligible entrants.
- 9. Prize:** Two (2) Prizes with an approximate retail value of Three Hundred and Fifty Dollars each (\$350) (Meta Quest 2 Virtual Reality Headsets) will be awarded. The Prizes will be distributed to the potential winner upon receipt of the W-9 and the Affidavit/Release. Each Prize is not transferable and must be accepted as awarded. No substitutions other than those specified in these Rules may be made, except by the Sponsor, who reserves the right to substitute another prize of equal or greater value for any of the Prizes if the Prize or any portion thereof is not available for any reason as determined by the Sponsor in its sole discretion. The winner is responsible for any taxes and costs not specified above.



10. General Conditions: In the event that the operation, security, or administration of the Sweepstakes is impaired in any way for any reason, including, but not limited to fraud, virus or other technical problem, the Sponsor may, in its sole discretion, either: (a) suspend the Sweepstakes to address the impairment and then resume the Sweepstakes in a manner that best conforms to the spirit of these Official Rules; or (b) award the Meta Quest 2 Virtual Reality Headsets Prizes at random from among the eligible entrants entered into the Sweepstakes up to the time of the impairment. The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and should such an attempt be made, the Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. The Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited by law.

11. Release and Limitations of Liability: By participating in the Sweepstakes, individuals agree to release and hold the Sponsor and its officers, directors, trustees, employees, and agents, (the "Released Parties") harmless from and against any claim or cause of action arising out of participation in the Sweepstakes or receipt or use of any prize, including, but not limited to: (a) unauthorized human intervention in the Sweepstakes; (b) printing errors; (c) lost or late Entry Forms; (d) errors in the administration of the Sweepstakes or the processing of entries; or (e) injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from any Entrant's participation in the Sweepstakes or receipt of any prize. Individuals participating in the Sweepstakes further agree that in any cause of action, the Released Parties' liability will be limited to the cost of entering and participating in the Sweepstakes, and in no event shall the Released Parties be liable for attorney's fees. Individuals participating in the Sweepstakes waive the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages.

12. Publicity. Each participant hereby grants to the Sponsor of the Sweepstakes unrestricted perpetual permission to use their name, voice, photograph or other likeness in any and all publications in any media now known or hereafter developed, including, but not limited to, JADA, ADA.org, ADA News, ADA New Dentist News, ADA Professional Product Review or the Internet, without compensation or notice, for any purpose, including, without limitation, the award of the Sweepstakes Prizes or publicizing the Sweepstakes, the Sponsor and/or Sponsor's business.

13. Disputes: Except where prohibited, each participant agrees that any and all disputes, claims and causes of action arising out of, or connected with, the Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in the State of Illinois. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, participants' rights and obligations, or the rights and obligations of the Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of Illinois, without giving effect to any choice of law or conflict of law rules (whether of the State of Illinois or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Illinois.
