

What is the ADAT's purpose?

- The purpose of the ADAT is to provide advanced dental education programs <u>and</u> advanced placement programs with insight into applicants' potential for success in their program.
- The ADAT helps programs select the candidates who are <u>best</u> <u>prepared</u> to succeed.





What does the ADAT assess?

The ADAT assesses knowledge and skills in three key areas:

- **1.** Biomedical Sciences
- 2. Clinical Sciences
- 3. Data, Research Interpretation, and Evidence-based Dentistry

Key Facts

 The ADAT is administered each year from March through August (6 months).

• The examination contains 200 multiplechoice questions and requires 4.5 hours to administer.


Key Facts

- The ADAT is administered at Pearson VUE test centers located throughout the U.S. and Canada.
- Retesting policy
 - Candidates may test two times per calendar year.
 - Attempts must be separated by a minimum of 45 days.
 - Candidates who have taken the ADAT two or more times previously will be limited to one testing attempt per calendar year and will need to submit evidence that they have actively applied to advanced dental educations programs within the previous 18 months.
- 2024 Fees
 - Examination fee: \$430
 - Additional ADAT score reports: \$50 (per report)



ADAT Results Reporting

- ADAT candidates receive four scores:
 - ADAT Overall
 - Biomedical Sciences
 - Clinical Sciences
 - Data, Research Interpretation, and Evidence-based Dentistry
- The ADAT Overall score indicates <u>critical thinking in</u> <u>dentistry</u> and is a weighted average of the three discipline-based scores.





ADAT Results Reporting


- ADAT results are distributed through ADEA PASS, ADEA CAAPID, and through the Department of Testing Services (DTS) Hub
 The DTS Hub is an online score reporting portal developed by the ADA
- ADAT results are made available within 4 weeks of a candidate's test date.
 - It's common for ADAT results to be released within <u>2 weeks</u> of the candidate's test date.



How widely used is the ADAT?

- The ADAT launched in 2016 and has just completed its ninth year.
- More and more candidates are choosing to take the ADAT.
- 2024 saw more ADAT administrations than any other year in the examination's history.

ADAT Administrations, by Year: 2016-2024






How widely used is the ADAT?

- Most advanced dental education programs currently accept ADAT results; many programs <u>require</u> them.
- The ADA thanks those programs who have championed the ADAT and require its usage. This really helps the success of the ADAT program!

How are advanced programs using ADAT results?

- Advanced programs make their own decisions about how to use ADAT results.
- Some programs <u>require</u> all applicants to submit ADAT scores.
 - This provides these programs with a standardized data point they can use to compare applicants from different pre-doctoral education programs.
- Some programs don't require ADAT results but consider them if they are submitted.
 - "If ADAT result is there I will look at it."
- Some programs use ADAT results only in certain prescribed situations.
 - "I will use this information if it helps to qualify candidates."
 - "Would use testing where applicants do not have class ranks or grade point averages."



Advanced programs see value in ADAT results

 The ADA has received valuable positive feedback on the ADAT from many advanced dental education programs:

"The ADAT test has the potential to be very helpful for decision makers, and especially for evaluating candidates from schools without ranking or formal grading practices."

"Considering using the ADAT because many institutions have gone to P/F and no class ranking. No data to rank candidates."

"The data seems promising and the program will in the near future consider mandating ADAT in applications."

"Looking forward to seeing how we can use this for our Qualifying Program applicants."

"Will be considering requiring ADAT [in] the future."

"We use ADAT when they are available as a quantitative measure relative to other candidates and relative to a scoring benchmark to assess student performance. GRE scores, which are required by most programs, are used more frequently due to the more widespread availability. As schools become more Pass/Fail, we lack any measure of quantitative measures to evaluate student performance, so any exam results are of assistance to narrow down the applicant pool."



Why should programs <u>require</u> the ADAT?

- ADAT scores provide a reliable, valid, fair, and <u>standardized</u> data point that programs can use to compare applicants from different pre-doctoral education programs (e.g., programs that use pass/fail grading, are <u>not</u> accredited by CODA, and/or are experiencing grade inflation).
- A program benefits most when ADAT scores are available for <u>every</u> applicant.
- ADA continues to recommend that ADAT results be part of a holistic admissions framework.



ADAT vs. INBDE

- ADAT scores help admissions officers differentiate between highperforming applicants.
 - i.e., The ADAT contains challenging content that can separate strong applicants from <u>extremely strong</u> applicants.
- The Integrated National Board Dental Examination (INBDE) is <u>not</u> designed to differentiate between high-performing candidates.
 - The INBDE is designed to identify candidates who lack the <u>minimum</u> level of knowledge and skills required for the safe practice of general dentistry.
- The ADAT is the stronger tool for identifying the candidates who are best prepared for advanced education or advanced placement.


- ADAT candidates continue to report positive test-taking experiences.
- The vast majority of candidates (94%) indicate the Pearson VUE test centers are conveniently located.

 95% of ADAT candidates indicate they are satisfied with the Pearson VUE testing environment.






ADAT candidates report positive experiences








ADAT Overall Scores (2024)

- This graph from the ADAT User's Guide shows the ADAT Overall scores that were earned in 2024.
- Most candidates earned ADAT Overall scores between 300 and 650.
 - Only the top performing candidates earned ADAT Overall scores above 650.
- The dark, curved line shows percentile standing.

ADAT Percentiles (2024)

For the ADAT Overall scale:

- A score of **700** puts a candidate at the 99th percentile (i.e., 99% of candidates score 700 <u>or below</u>).
- A score of 600 puts a candidate at the 93rd percentile.
- A score of **500** puts a candidate at the 55th percentile.
- A score of **400** puts a candidate at the 15th percentile.



- Here are the 2024 percentiles taken from the ADAT User's Guide.
- This candidate's ADAT Overall score puts them in the 78th percentile. This means only 22% earned a higher ADAT Overall score in 2024.





 Relative to other candidates, this candidate performed <u>strongest</u> in Clinical Sciences (85th percentile) and <u>weakest</u> in DRIEBD (42nd percentile).


- Here are the 2024 score averages taken from the ADAT User's Guide.
- This candidate scored <u>above average</u> in each area except Data, Research Interpretation, and Evidence-based Dentistry (DRIEBD).

- The graphs in the ADAT User's Guide are also helpful for understanding candidate performance.
- From the graph, I can see that this candidate's ADAT Overall score of 550 falls in the <u>upper half</u> of the 2024 score distribution.


The candidate's Biomedical Sciences score of 550 also falls in the <u>upper half</u> of the 2024 score distribution.

Biomedical Science Scores: 2024




 The candidate's Clinical Sciences score of 580 appears to fall in the <u>upper</u> <u>quarter</u> of the 2024 score distribution.

Clinical Science Scores: 2024






 The candidate's Data, Research Interpretation, and Evidence-based Dentistry score of 470 falls in the lower half of the 2024 score distribution.





Has the ADAT been validated?

- Since 2016, the ADA has accumulated strong validity evidence in support of the ADAT.
- Each year, we strive to strengthen existing validity evidence for the ADAT and provide new evidence where possible.
- Our validation efforts for the ADAT are guided by the Standards for Educational and Psychological Testing (AERA, APA, and NCME, 2014).





What validity evidence supports the ADAT?

• Two primary types of validity evidence support programs' use of the ADAT:

Content-oriented validity evidence

- Evidence that the content domain for the ADAT is appropriate, given the examination's purpose.
- Evidence that the questions on the examination provide an adequate sampling of the established content domain.

Convergent validity evidence

 Evidence that scores on the ADAT are positively correlated with measures of related constructs (e.g., dental GPAs).



What <u>content-oriented</u> validity evidence supports the ADAT?

Content Validity Evidence:

- The disciplines covered on the ADAT are based on findings from a survey on advanced dental education conducted by an ADA Task Force and ADEA.
- The test specifications for the Clinical Sciences section are based on the test specifications for the National Board Dental Examinations (NBDE) Part II, which were informed by the results of a practice analysis involving entry-level general dentists.
- The test specifications for the Biomedical Sciences section are based on the test specifications for the NBDE Part I which involve the key biomedical sciences thought to underlie dental practice.
- The test specifications for the Data, Research Interpretation, & Evidence Based Dentistry section were constructed based on subject matter expert input, and guidance from the ADA Science Division and its Center for Evidence-Based Dentistry.



What <u>content-oriented</u> validity evidence supports the ADAT?

Content Validity Evidence (continued):

- Each ADAT form is built to meet detailed content specifications which dictate the number of questions administered from each discipline and sub-discipline of the domain.
- The ADAT content specifications are reviewed by the Council on Dental Education and Licensure (CDEL) each year.
- ADAT questions are written by highly qualified test constructors whose qualifications match the needs dictated by the content specifications. All test constructors' qualifications are reviewed by CDEL.
- ADAT test constructors can recommend updates to the ADAT content specifications for consideration by CDEL and its Dental Admission Testing Committee.



What convergent validity evidence supports the ADAT?

 A study by DeSantis et al. (2018) found that ADAT scores were positively correlated with several indices of ability in a sample of residency program applicants.

> The correlation between applicants' ADAT Overall scores and dental school GPAs was .64

> The correlation between applicants' ADAT Overall scores and dental school class ranks was .60



What convergent validity evidence supports the ADAT?

- Analysis conducted by the ADA in 2024 also indicates
 ADAT scores show a positive relationship with dental school GPA.
- For the ADAT Overall scale, examinees reporting dental school GPAs above 3.5 performed 1.2 standard deviations better than examinees reporting GPAs of 2.5 or below.



Average ADAT Score, by Dental School GPA: 2019-2024 (3,362 administrations)



How reliable are ADAT scores?

ADAT scores are highly reliable.

- Reliability estimates for **ADAT Overall** scores have exceeded .90 in each of the past three years.
- Reliability estimates for the other three reporting areas often approach or exceed .80.

The ADAT Overall score is a highly reliable indicator of a candidate's overall critical thinking skills in dentistry.

What other validity evidence supports the ADAT?

- ADAT administrations occur under standardized testing conditions that are closely monitored
 - Deviations from standardized testing conditions are reported to DTS by the test administration vendor (Pearson VUE).
- All ADAT questions are pretested (i.e., "tried out") before they are used operationally
 - Non-performing questions can be flagged and withheld from operational use
- The ADAT is implemented by the ADA's DTS, an organization with decades of experience implementing high stakes testing programs
 - DTS employs professionally trained staff that includes individuals with advanced degrees in Psychometrics, Educational Psychology, Industrial/Organizational psychology, and Leadership



What about fairness?

- Fairness is fundamental to validity (AERA, APA, and NCME, 2014). DTS strives to develop examinations that are fair for all candidates.
- DTS and our partners employ well-defined standard operating procedures and policies to help ensure that all candidates are treated fairly and equitably before, during, and after the examination.
- DTS test development staff and test constructors are trained to identify and avoid content that could introduce *construct irrelevant variance (CIV)* into examination results. Dedicated Fairness and Sensitivity reviewers evaluate examination content during the development stage, so any concerns can be addressed before the content is used operationally.
 - CIV could include language, concepts, or objects that might be familiar to certain groups but not others, in a way that is
 irrelevant to the concept being tested (extraneous).
