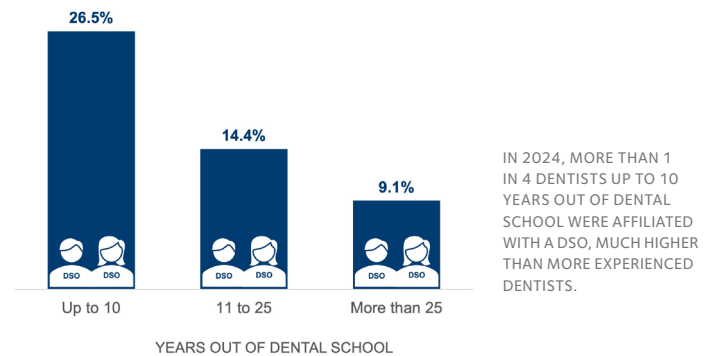

Insurance Reform & Transparency

- Worked to introduce bills that will ensure that many of the state insurance patient protection laws apply to enrolled patients regardless of how their dental coverage is contracted. Advocacy is ongoing for federal dental insurance reform to protect patients, support dental practices and bring much-needed balance to insurer-provider contracting nationwide.
- Enacted more than 235 new state Dental Insurance Reform laws in the last decade (38 in 2025 alone), with ADA supporting these efforts with advocacy grants and shared expertise.
- Pressed for Medicare Advantage reform to include meaningful dental benefits

Fair, transparent insurance helps patients use the benefits they deserve.

Access to Care

- Secured federal investments in workforce training, and prevention programs.
- Supported many states in their advocacy campaigns to improve Medicaid. So far in 2025, 11 states, many of which partnered with the ADA, have increased funding and dental care services leading to improved access for Medicaid enrollees.
- Defended community water fluoridation, helping 16 states and multiple localities defeat anti-fluoride legislation and preserve access to fluoride supplements stopping a ban by the FDA.

Science-based advocacy keeps prevention within everyone's reach.

Workforce Solutions

- Protect and sustain federal investments in oral health programs on an annual basis, including workforce training, oral health education, disease prevention, dental research and Indian health.
- Scope expansion for team members through proven training methods allowing better, faster delivery of care without compromising quality or patient safety, including Expanded Function Dental Assistants (EFDAs) and Oral Preventive Assistants (OPAs).
- Ease workforce challenges by supporting the Dentist and Dental Hygienist (DDH) Compact, removing barriers for licensed dentists and hygienists to easily move across state lines to practice in other states.

Student Debt Solutions

- Advanced Resident Education Deferred Interest (REDI) Act to pause interest accrual during residency and expand repayment flexibility for dentists, especially those practicing in underserved areas.
- Advocated for continued Public Service Loan Forgiveness funding.
- Supported new service-based loan repayment and training programs through FY 2026 federal funding, bolstering the dental workforce.

Lower debt means more dentists in communities that need them.

WHAT ARE LIVING GUIDELINES?

Traditional guideline development typically takes more than 2 years to complete. In contrast, **living guidelines are proactive**. The process continuously monitors literature for new evidence and data, allowing for individual recommendations to be updated regularly. This results in more relevant recommendations that can be implemented in real-time.

Guidelines contain methodologically and rigorously developed recommendations formulated by a panel of subject matter experts, researchers, and patient partners that are informed by research evidence which are then used to make informed clinical and policy decisions.

HOW ARE TOPICS DETERMINED?

Living guideline topics and priorities will be defined by an advisory panel of interest-holders across the U.S. oral health system and developed by independent panels with multi-disciplinary backgrounds, with methodological support from the ADA and University of Pennsylvania School of Dental Medicine.

WILL THE PROGRAM DEVELOP NEW GUIDELINES OR UPDATE EXISTING GUIDELINES?

Both — this innovative program will develop new guidelines and update existing guidelines, in addition to identifying areas that require more research.

HOW SHOULD CLINICIANS IMPLEMENT THESE GUIDELINES?

The purpose of creating a guideline is to achieve better health outcomes. Living guidelines allow dental professionals and clinicians across many disciplines to use this information as it becomes available to inform and advance patient care. Clinicians are encouraged to follow a balanced, patient-centric approach when integrating recommendations into practice.



The ADA Living Guideline Program is a breakthrough in clinical care. By delivering frequently updated, evidence-informed recommendations, this innovation empowers dentists with the most current chairside guidance to deliver high-quality patient care.
