

## Commission on Dental Accreditation Unofficial Report of Major Actions August 4-5, 2016

1. The Commission reviewed accreditation reports and took 325 accreditation actions on dental, advanced dental and allied dental education programs and recorded one (1) mail ballot on an advanced dental education program.

A total of five (5) new programs were granted accreditation:

Two (2) dental assisting education programs and one (1) oral and maxillofacial surgery education program received a formal warning that accreditation will be withdrawn in February 2017 unless the requested information, demonstrating compliance with the accreditation standards, is submitted prior to that time.

The Commission affirmed the reported voluntary discontinuance effective date or planned closure date of two (2) dental assisting education programs, two (2) dental hygiene education programs, two (2) general practice residency education programs and one (1) prosthodontics education program, at the request of their respective sponsoring institutions.

- 4. The Commission directed that the newly appointed Dental Therapy Site Visitors participate in a two-day training workshop in Chicago in December 2016 and that Research and Development Funds be used to support this activity.
- 5. The Commission reviewed the report of the Standing Committee on Finance and took several actions, including:
  - Directing submission of a resolution to the ADA Board of Trustees or House of Delegates, as appropriate based upon consultation with the ADA Speaker of the House, to recommend that the ADA and CODA cooperatively establish and adopt a shared services formula related to CODA's indirect expenses, which is documented in the ADA-CODA Memorandum of Understanding.



- Directing submission of a resolution to the ADA Board of Trustees encouraging the Board to sponsor an informational session on CODA's budget process during the ADA 2016 Annual Meeting, with assistance from CODA leadership and staff.
- Directing the Standing Committee on Finance to establish a timeline (long-term plan) by which CODA will assume its total expenses (direct and indirect) and compensate the ADA annually for indirect expenses.
- Directing submission of a resolution to the ADA House of Delegates requesting a revision to the ADA *Bylaws*, Duties of the Commission to grant CODA sole authority to determine and manage its annual operating budget, with Board oversight (not approval) as a fiduciary responsibility of the Association.
- 6. Prior to the Commission's summer meeting, the Commission conducted a one-half day strategic planning mega issue discussion. The Commission reviewed the report of the Standing Committee on Quality Assurance and Strategic Planning and took several actions, including:
  - Adopting the proposed Mission, Vision, and Values statements, and the proposed 2017-2021 CODA Strategic Plan, effective January 1, 2017.
  - Revising documents which contain the Mission, Vision, and Values statements, effective January 1, 2017.
  - Directing submission of a resolution to the 2016 ADA House of Delegates to amend CODA's *Rules* to incorporate the new Mission statement, effective January 1, 2017.
- 7. The Commission adopted the following revised policies with immediate implementation:

- 8. The Commission reviewed the report of the Standing Committee on Communication and Technology, and took several actions, including:
  - Directing development and deployment of a follow-up survey to the 2012 CODA Communication Survey, with a report of findings to the Standing Committee on Communication and Technology and the Commission for consideration during the Summer 2017 meeting.
  - Directing assessment of the need for an independent CODA website using one of its acquired website domains in accord with the Strategic Plan, with a report to the Standing Committee on Communication and Technology and Commission in Summer 2017.
  - Directing inquiry with the American Dental Association to determine if there can be a modification to the expense of development and annual recurring expenses associated with the Aptify electronic accreditation program.
  - Directing investigation of electronic accreditation business tools available and utilized by other professional accreditation organizations.
  - Directing development and deployment of a survey of dental and dental related education programs to investigate the electronic accreditation tools used in academic settings and additionally the important aspects educational programs would like to see in an electronic accreditation platform used by the Commission.
- 9. The Commission reviewed the report of the Standing Committee on Nominations and approved nominees to fill vacancies for discipline specific positions and non-discipline specific positions on its Review Committees beginning November 2016.
- 10. The Commission elected Dr. Harold "Mark" Livingston as chair of the Commission and Dr. William Leffler as vice-chair of the Commission for 2016-2017.
