The applicant shall be of good professional character and 18 years of age or older. II. Any person applying for any license or privilege under this chapter, including any person seeking to convert from inactive to active status, shall provide the office with information relating to dental competence and professional conduct, to permit the office, based on criteria established by the board, to make a decision that the applicant possesses sufficient competence and character to be issued a license under this chapter. III.
